LOCAL 50 WAGE RATE SHEET RESIDENTIAL DIV. AGREEMENT EFFECTIVE 7/1/19 --7/5/20

The amended agreement calls for wage increases on July 1, 2017 of \$0.93 per hour; July 2, 2018 of \$0.96 per hour; July 1, 2019 of \$0.96 per hour.
July 6, 2020 of \$1.02 per hour

These rates will be good from July 1, 2019 through and including July 5, 2020.

The changes on this report from the last is an increase of \$0.91 to the Base Rate, increase of \$0.05 to the retirement, and an increase of \$0.08 to the cont. fund.
